School Council approved budgets for the 2022-2023 school year were received in good order and contained the required data. The board noted the good work done by Principals, Treasurers, School Council chairs and the Finance Officer.

Question regarding deficit budgets being presented by some schools – is this acceptable? for how long? All schools carry varying DDF balances that can be used to cover where required. Schools with deficits had rationale and initiatives to work on to change the financial outcome for the school year. The BOD will monitor this for trends and consider action if necessary to maintain fiduciary responsibility by School Councils and CISPG policies.

Chris is working with CISVA to collaborate and encourage Irish trained teachers to come to Canada and teach in BC. CISVA has already started the process and
